INSTRUCTION TO BIDDERS

Islamic Relief is an international aid and development charity, which aims to alleviate the suffering of the world's poorest people. It is an independent Non-Governmental Organization (NGO) founded in the UK in 1984. With an active presence in over 40 countries across the globe, we strive to make the world a better and fairer place for the three billion people still living in poverty. As well as responding to disasters and emergencies, Islamic Relief promotes sustainable economic and social development by working with local communities - regardless of race, religion, or gender.

At the international level, Islamic Relief Worldwide (IRW) has consultative status with the UN Economic and Social Council and is a signatory to the International Red Cross and Red Crescent Code of Conduct. IRW is committed to the Sustainable Development Goals (SDGs) through raising awareness of the issues that affect poor communities and through its work on the ground. Islamic Relief are one of only 13 charities that have fulfilled the criteria and have become members of the Disasters Emergency Committee and is certified by CHS.

IR started operations in Kenya in 1993 through a local CBO in Mandera District, Northern Kenya. It opened its fully-fledged office in March in 2006 at the height of drought in the Horn of Africa. Since then, it has been providing humanitarian and development assistance to vulnerable communities. Over the years IRK has remarkably changed the lives of vulnerable and disadvantaged communities.

Qurbani means sacrifice. Every year during the Islamic month of Dhul Hijjah, Muslims around the world slaughter an animal – a goat, sheep, cow or camel – in remembrance of the sacrifice that Prophet Ibrahim (A.S.) made out of his strong faith in Allah. Ibrahim (AS) showed a willingness to sacrifice his son Prophet Ismail (A.S.) but his son was replaced with a lamb by Allah. Allah was so pleased with Ibrahim's (A.S.) submission to Him that He made this demonstration of sacrifice and faith a permanent part of a Muslim's life. This event is mentioned in Quran - Surah As-Saffat (37:102). Hence, every year on the 10th of Dhul Hijjah, Muslims all over the world celebrate Eid Al Adha. On this day, Muslims slaughter a lamb, sheep, goat, or a camel to honour the sacrifice of Ibrahim (AS). Both Eid ul Fitr and Eid Al-Adha have great significance in Islam.

The Qurbani (Udhiya) Programme is implemented in the first three to four days of Eid al Adha, commencing from the tenth day of the month of Dhul Hijjah. It enables those who can afford to donate their qurbani to the poor and needy. The projects involve the distribution of fresh meat to the most vulnerable people, such as women, children, the elderly and persons with disabilities. Each meat pack is designed to consist of meat that is appropriate and acceptable for the dietary culture of the communities we serve.

Islamic Relief Kenya is currently focusing on four main thematic areas i.e. Empowering communities and changing lives, responding to Lifesaving and humanitarian emergencies. addressing global and local root causes of Poverty, humanitarian and climate Crisis as well as strengthening organizational capability to ensure organizational sustainability.

Islamic Relief Kenya is planning to undertake the procurement of live sheep/goats for Qurbani, slaughtering, packaging, and distribution of fresh meat for qurbani 2026 to rights holders. the program scheduled for **27th to 30th May 2026** (subject to change depending on the sighting of the moon-Dhil-Hijja)

Note: Please note that interested vendors' bids should be inclusive of the purchase of live animals, transportation to the sites, slaughtering, and branded packaging and distribution. Distribution will be carried under the supervision of Islamic Relief Kenya staff.

Application and Submission Requirements

The invitation for the bids is open to all interested eligible Companies who are duly registered and in possession of valid documents.

Bidders are required to submit a complete tender document in PDF format (maximum file size: 25MB), with the email subject line clearly indicating the tender name and location, to **tenders@islamic-relief.or.ke** on or before **07 April 2026 at 11:00 AM**, and any submissions received after this deadline shall be rejected and not considered.

Note: Applications submitted through any other channels or to email addresses other than tenders@islamic-relief.or.ke will not be accepted.

Single PDF Document: Each bid must be submitted as a single, consolidated PDF document (Max 25mb). Multiple or fragmented submissions will not be accepted.

Bidder Email: Interested bidders may submit their bids **ONLY** from the official email address of the bidder or company

Direct PDF Attachment Only: Bid documents must be attached directly as PDF files in the submission email. Links to external file-sharing platforms, such as Google Drive or Dropbox, are not permitted and will not be reviewed.

Subject Line Specification: Bidders must include the tender **Name and Location** in the email subject line to ensure proper filtering and identification of submissions.

1. Scope of work

Supply and delivery of live goats/sheep, slaughtering, packaging, and distribution of fresh meat for Qurbani 2026 to right holders in Banisa Sub County, Mandera County as per table below.

Note: The number of animals may increase, subject to additional funding, through an addendum.

Selected bidders shall deliver live goats/sheep to the distribution site, slaughter them, package them in branded bags, and distribute them to the rightful holders under the supervision of Islamic Relief Kenya (IRK).

Distribution timeline: Eid al-Adha 2026 (27th to 30th May 2026) (subject to change depending on the sighting of the moon-Dhil-Hijja). Any **delivery after these dates will not be accepted.**

2. Eligible Bidders

The invitation for the bids is open to all interested eligible Companies who are duly registered and in possession of valid documents.

3. The live sheep/goats being supplied must meet the following criteria:

1. Must be 2 years and above
2. Must be at least 24 Kgs dry weight
3. Must be complete without any abnormality
4. The Goats/Sheep must meet all the criteria/standards which are as follows:
5. Should not be blind or mono-eyed, should have full ears with no defects at all.
6. Should not be physically disabled and have a deformity of any kind (i.e., it should not have broken horns)
7. The animals should be fat, healthy, and strong.
8. Animals must have most of their teeth intact. Animals with no teeth at all are not eligible, but if only a few are missing, they may still qualify.
9. The animals MUST not be recently Vaccinated and Dewormed
10. The animal must be healthy, active and reactive when approached
11. Have fine hair that is shiny and does not fall off easily
12. Should be in normal condition, backbone is straight, horns are balanced, and the legs are symmetrical
13. Animals should be checked for proper body weight, height, and harmony, and be free from visible physical defects.

14. Animals must be fat, healthy, and strong, capable of withstanding the journey and sacrifice process.

Note: Representatives from Islamic Relief Kenya, a religious leader, a veterinary officer, and a public health officer, will conduct an inspection of the live animals. Any animal that does not meet the above required standards will be rejected, and the supplier will be required to replace the rejected animal immediately.

Slaughtering

All livestock for Qurbani will be slaughtered after the Eid prayer on 10th Dhul Hijjah, before sunset on 13th Dhul Hijjah. The livestock slaughter will be conducted in a Halal slaughterhouse or a community-based slaughter site, designed to comply with the ritual slaughter and certified for Halal and hygiene requirements. The slaughter should also be conducted by skilled and experienced practicing Muslims.

Until the time of the slaughter, animals should be kept humanly, well-fed and watered.

Packaging

The packaging sack should safely and comfortably carry at least 10 kg of meat while maintaining quality and hygiene standards. The outer layer of the sack should be of a sturdy material like woven polypropylene (PP) or high-density polyethylene (HDPE) to provide strength and tear resistance. The inner lining should be made of food-grade material, ensuring food safety and prevent leakage. The sack should have reinforced handles/straps made of the same material as the sack itself. The sack will feature printed information branded with the name of organization and logo in blue color.

Cost of Bidding

The bidders shall bear all costs associated with the preparation and submission of its bid & IRK will in no case be responsible for those costs, regardless of the conduct or outcome of the bidding process.

6. Amendment of Bidding Document

At any time prior to the deadline for submission of bids, IRK May for any reason, at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents & will be binding on them. The amendment will be notified in writing of all prospective bidders, who have received the bidding documents & will be binding on them. To allow prospective bidders to take the amendment into account in preparing their bids, IRK may, at its discretion, extend the deadline for bid submission.

7. Language of the Bid

The bid prepared by the bidder, as well as all correspondence & documents relating to the bid, supporting documents, and printed literature furnished by the bidder, shall be written in the English language.

8. Bid Document Comprises.

The bidding prepared by the bidder shall comprise the following:

- Copy of ID/Passport for Company Owner/Director.
- Bid bond (10% or above of the quoted amounts valid for 180 days)
- Evidence of Past Experience in similar work done the past three years e.g., signed Contract/PO Delivery Note and completion certificate.
- List of referees with their contact details (Name, telephone number, official emails with referee title, location).
- Certification of Mandatory document
- Serialization of bid documents using paginated numbering machine
- Bank statements for the last six months i.e., 1st September 2025 – 28th February 2026
- Letter of credit

9. Bid Currencies

The bid prices shall be quoted in Kenya Shillings (KES).

10. Bids Prices

- The potential contractor shall submit his/her bid as indicated in Annex I.
- The bidders shall indicate the price per goat/sheep and the total bid price.
- Prices quoted by the bidder shall be fixed for **Sixty (60) calendar days** from the date of Tender opening. Price changes during the bid validity period after the contract award will not be accepted.

11. Delivery

Delivery to be from **27th – 30th May 2026** (subject to change depending on the sighting of the moon- Dhil-Hijja).

12. IRK's right to vary quantities at the time of the award

IRK reserves the right at the time of the award of the contract to increase or decrease without change in the price per goat/sheep or other terms of condition.

13. IRK's right to accept any bid and/or reject any or all bids

IRK reserves the right to accept any bid and annul the bidding processes and reject all bids at any time prior to the award of the contract, without, thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders on the grounds of its action.

14. Submission of Bids

15. Evaluation

15.1 IRK will examine the tender documents to determine completeness, general orderliness, sufficiency in responsiveness, price, and product brand.

15.2 The potential supplier shall not contact IRK on matters relating to their bid from the time of opening to completion and official communication sent to them.

Any effort by the potential supplier to influence IRK in the evaluation shall result in disqualification.

15.3 Evaluation will be based on meeting the minimum criteria regarding the applicant's legal status, general and particular experience, personnel and financial position as demonstrated by their responses as set in clause 8.

15.4 The applicants **MUST** have registered offices and IRK reserves the discretion of visiting physical premises from which the applicant conducts business if so desired to confirm the existence and capability to deliver the assorted items.

15.5 Due diligence shall be undertaken and any bidder found to be in breach by providing false information shall be disqualified.

16. Employment of Minors

The supplier shall not employ children in executing the contract. The Contractor shall observe international conventions relating to child labour namely the UN Convention No.182 on worst forms of child labour and Convention No. 138 on the minimum age for admission to employment.

17. Criminal Act

The supplier undertakes to comply with all applicable laws and to ensure that it does not engage in any kind of criminal activity including but not limited to bribery, fraud, corruption, terrorism and to maintain ethical business practices as well as not to commit any Prohibited Acts defined as:

1. To offer, promise or give any person a financial or other advantage.
2. To request, agree to receive or accept any financial or other advantage not expressly provided for as an inducement or a reward for the performance of any function or activity in connection with this Agreement.
